# OMWD Board Considers Budget for Fiscal Years 2025 and 2026 Which Includes Internal Cost Control Measures in the Face of Impending Extraordinary Cost Increases From Its Wholesaler

At its April board meeting, OMWD's Board of Directors reviewed a draft budget for Fiscal Years 2025 and 2026 which reflected board direction for OMWD to control its internal costs in order to mitigate the impact to customers of an impending wholesale water price increase expected next year. OMWD staff presented a budget that includes freezing hiring for vacant positions and delays in previously planned positions, a reprioritization of spending on critical capital projects, and delays in select projects.

Capital projects to be funded over the next two years are those needed to sustain operations such as replacing aging pipelines and making improvements at OMWD's water treatment plant and water reclamation facility. Additionally, over \$4 million in costs for these projects will be offset by state and federal grants. There will be no cuts or impacts to the level of customer service for OMWD ratepayers. The board is scheduled to approve the final budget at its June 19 meeting.

What is still unknown is the cost of water OMWD will be required to pay its wholesaler, the San Diego County Water Authority.

OMWD initially assumed a 5% increase in SDCWA's wholesale rate for 2025, based on direction that SDCWA provided in 2023. However, in April, SDCWA announced that it expects to hike its prices as much as 39% over the next three years, and up to 20% alone in 2025.

OMWD purchases 100% of its drinking water supply from SDCWA. As OMWD has prepared a budget that controls its own costs, approximately 90% of any rate increase ultimately imposed by OMWD for 2025 will be attributable to SDCWA's wholesale rate.

SDCWA will host on June 27 its public hearing, where public input is invited, on this wholesale rate increase for 2025. Public comments may be made at any time prior to the meeting up until the public hearing closes on June 27 by submitting a comment to **publiccomments@sdcwa.org** or in person at the meeting at 4677 Overland Avenue in San Diego.

# **State Water Board is Proposing New Water Regulations**

California's State Water Resources Control Board is developing water use efficiency regulations that would affect how much water OMWD can provide to customers. The proposed regulations would impose limits that would be in effect whether it's a wet or dry year, regardless of water supply conditions. Further, the regulations could have an impact on water rates. What can OMWD customers do to stay informed?

# Elfin Forest Interpretive Center Honoring Susan J. Varty Celebrates Its 15th Birthday!

This year, Elfin Forest Interpretive Center Honoring Susan J. Varty celebrates fifteen years of educating and inspiring visitors to feel connected with nature. First opened in June 2009, this one-of-a-kind facility is the result of the collaborative efforts of OMWD and the Escondido Creek Conservancy to provide visitors with educational and environmental experiences.

The facility was designed by the late James Hubbell, known for his art and architecture inspired by nature. The building features green design elements such as recycled building materials, solar panels powered by photovoltaic cells, and a green "living" roof. The center was named after former OMWD board member Susan J. Varty, who was a fierce advocate of the environment and who was instrumental in the partnership that led to the center being built.

# **Trouble on the Colorado River**

The Colorado River is a major source of water for Southern California, including OMWD customers. Supplies on the river have been declining for decades due to perennial drought conditions. As a result, reservoirs along the river that support Southern California, such as Lake Powell, are now at low levels. Further complicating things, damage has been discovered on outlet pipelines on the Glen Canyon Dam that could limit the amount of water being released downstream of Lake Powell, potentially impacting water supply to San Diego County.

The damaged pipelines are used for water releases only when Lake Powell's volume falls to very low levels. The damage has caused thinning in the pipeline walls and continued use could cause further deterioration. The pipelines are being relined as a short-term fix, and state and federal agencies are working to find a long-term solution for the damaged water outlets. The dam's ability to release water when at low levels is vital to help ensure water reliability for the millions of residents who live downstream.

# Rebates Now Available for Flow Monitoring Devices

OMWD customers can now apply for rebates on flow monitoring devices. Select models can automatically shut off water to the home when a leak is detected, potentially preventing costly damage and an unexpectedly high water bill.
